

Apply for Visa Information of the People's Republic of China

1. Basic documents

1	Original Passport	with at least six months of remaining validity and 3 blank visa pages.
2	Copy of passport	data page, observation page and the page with previous Chinese visa.
3	Visa Application Form of the People's Republic of China	a truthfully, fully and correctly filled Application Form with a recently-taken color passport photo (bare-head, full face) against a white background attached.
4*	Proof of legal stay or residence status in Myanmar	*only applicable to non-Myanmar citizen;
	Copy of the page of passport with Myanmar Immigration's stamp for entry	*"proof of legal stay or residence status" refers to Myanmar visa, stay permit or FRC(Foreigner Registration Certificate) etc.
5*	Original letter of consent by applicant's parents	*only applicable to the applicant who is under 18 years;
	Copies of parents' ID	*"letter of consent by applicant's parents" shall be written in English and signed by parents, notarized by Myanmar notary authority;
	Original and copy of certification of family relation	*"certification of family relation" refers to Birth Certificate or Household Register.

**Note:

1. According to the principle of equivalent, Visa fees for non-Myanmar citizens may be different. The exact amount will be noticed on the pick-up form.
2. Rush service is available after the approval by Visa officer. Passport can be collected in the next working day and 25 US dollars as the rush service fee will be charged.

3. After the application being accepted, the applicant should make the payment in ICBC(Yangon Branch)(Industrial and Commercial Bank of China) during the next working day and collect passport in Chinese Embassy at the afternoon of the date noticed on pick-up form or noticed by telephone.
4. Visa failed to be collected over 3 months will be cleared up.
